
## RESEARCH OBJECTIVES

## RESEARCH METHODOLOGY



## CONCEPT OF FRAMEWORK




## RESULTS

The high cost of treatment and the existence of price differences in the treatment of patients with hypertension can be caused by different patient conditions and already at an advanced stage.


